Subject:- 'Merit-cum-Means Loan subsidy Scheme' in self financing courses for the session 2020-2021.

Dear Sir/ Madam.

This is to inform you that a student who has taken education loan from any nationalized bank for undertaking any partially self-financing Graduate/Post-Graduate courses in the University shall be eligible to apply for loan subsidy subject to fulfillment of conditions as below.

- 1. The amount of loan subsidy shall be equal to 20% of the loan availed by the student subject to the cap of Rs. 50,000/- in each case.
- 2. The family income of the student applying under the scheme must not exceed Rs.4.80 lacs in support of which the student shall submit an affidavit duly attested

by the Executive Magistrate along with the application for loan subsidy.

- 4. The loan subsidy shall be released directly to the bank after completion of the course subject to the following conditions:
  - (a) The student has secured 60% marks or equivalent grade throughout the Course and would complete his/her degree within specified duration.
  - (b) The student has submitted a certificate from the loan sanctioning bank to the effect that the amount of education loan has been fully disbursed to the student.
  - (c) The Student has not availed any financial assistant from any other source.
- 4. The total number of students qualifying for this loan subsidy shall depend upon the number of applicants, the amount of loan subsidy due as per the formula given above and the amount of income available for disbursement under the scheme. However, in case the number of applicant exceeds the limit of students that can be catered within the available amount then the subsidy shall be released to the students in order of merit.
- 5. An amended proforma of application and undertaking under scheme is enclosed.
- 6. This scheme would be applicable for the students completing the course in the session 2020-2021.

The students who fulfill the conditions as above and desirous to avail the said loan subsidy may apply for the purpose on the enclosed proforma. The said application should reach the office of the Account-II (Fee Checking), Panjab University, Chandigarh latest by 15<sup>th</sup> January, 2021. Incomplete applications will not be entertained and the applications received after the due date will be rejected.

This may kindly be brought to the notice of the students.
